WRA Legislative Report—The WRA strongly supports the property tax relief and additional school funding in the 2017-19 state budget bill. Gov. Walker's proposed budget will maintain the current levy limits on local governments, significantly increase K-12 school aids to fund education, and eliminate the state portion of the property tax levy. **Background**—The proposed 2017-19 state budget would increase school funding by \$650 million over 2 years, which would be the most state aid provided to K-12 schools over the last 10 years. The state budget maintains levy limits on local governments, which caps how much local governments can charge property owners to pay for local services. Walker's budget eliminates the state portion of the property tax, saving the average homeowner \$27 per year. **What's in play—Proposal:** The WRA supports the property tax relief and additional school funding and will work with the legislature to see these provisions signed into law with the passage of the state budget this summer

Alerts can be set up via www.supraekey.com. If you are new to this website, you will be prompted to set up an account (hint: your key serial number displays at the top of your ekey screen). Click here for detailed instructions on setting up showing alerts.**

****Granting Non-Member Access (NMA) to your Keybox**

****The status label for Pending has been changed to Offer-No Show to better describe what is represented and expected when listings are in this status.**

****E-mailed listings from Paragon, when viewed with a mobile device, will display using a more mobile friendly view. There is still an option to switch to the full desktop version of the report within each email.**

****The maximum character length of photo labels has been increased from 16 to 30.**

****Within Client Connect, you can now isolate Favorites, Possible, and Rejected listings by individual search when multiple searches are present.**

****Spell check within email has been restored.**

****Error when using Chrome version 57 when attempting to email has been resolved**

****If you are including a home warranty, use the new Includes field to indicate specifics such as type, cost and company.**

****If you have a listing that is not mapped correctly, it may be missed if an agent is searching by map. Please make it part of your routine**

to always check the map placement when adding a new listing. If the map placement is not correct, you can adjust it under Listing Maintain - Change GeoCode. When the map displays under maintain, click on the orange map placement marker and move it as needed. Switching to a bird's eye view (click the down arrow next to the word Road in the upper left corner) and using the zoom feature helps to pinpoint the exact location. There is also an option to enter the latitude and longitude. Before clicking Save, you may want to zoom out a bit as the zoom level will also be saved.

****Please make sure your seller dates all amendments the day of or prior to expiration date.**

****Please enter your sold property into "pending" (click save) then enter the sold information into Paragon™ with the exception of SBP (Sold Before Publishing). Rock County Housing Statistics

Madison, Wis. —Wisconsin's existing home sales slipped in February even as prices continued to grow at well above the rate of inflation. Home sales fell 2.6% in February and the median price rose 6.1%. By contrast, the annual inflation rate stood at 2.5% in January, the most recent month available.

The strong demand and limited supply has put significant price pressure on the existing home market. This has been a continuation of a recent trend. The market has shifted from a buyer's market just two years ago to a strong seller's market.

We've been lucky to have low mortgage rates and modest improvements in income to help offset the steadily rising prices over the last couple of years.

Rock County Housing Statistics—The median price for February 2017 is \$110,00 and for the month of February in 2016 it was \$118,000 that was a decrease of -6.8% and the Sales for February 2017 is 97 and February of 2016 was 114 that was a decrease of -14.9%.

Annual Housing Statistics—The median price for February 2017 was \$110,250 and for the month in February of 2016 it was \$125,450 that was a decrease of -12.1%. The sales for February 2017 was 220 and in February of 2016 it was 208 that was an increase of +5.8%.

All county figures on sales volume and median prices are compiled by WRA and are not seasonally adjusted. Median prices are only computed if the county recorded at least 10 home sales in the quarter. Beginning in 2010, all historical sales volume and median price data at the county level have been re-benchmarked using the Techmark system, which accesses MLS data directly and in real time.

2. Nominees should have contributed volunteer (unpaid) hours to a program that improves the livability of a community. The program's activities aren't limited to real estate or housing issues, and may include such things as crime prevention, youth mentoring, and homelessness prevention.
3. Nominees should have made a significant contribution of personal time, but contributions of money, materials, and other resources will be considered by the judges as well.
4. Nominees will be judged on level of personal contribution, impact of personal contribution, broadness of impact, and the project's suitability as a role model for other REALTORS®.
5. The award is intended to recognize individual contributions, not association- or company-wide efforts. If an individual within your company can be singled out as instrumental to the success of a group effort, he or she is eligible. If the achievements of two people (such as a married couple or co-founders of an organization) cannot be separated, they can enter as a pair and their entry will be considered as one.
6. Some portion of the nominee's community work must have taken place during the timeframe specified on the application form, but judges will also consider ongoing efforts outside that timeframe that demonstrate a depth of commitment.
7. Nominees should be able to document the results of their individual involvement through published reports and/or testimonials from the organization they served or the people they helped.
8. Nominations must be accompanied by a completed [entry form](#) to be considered (REALTORS® may nominate themselves or may be nominated by another NAR member, a state or local association executive, or the community organization they serve). You must submit an original and four copies of the entire entry package.

"Recipe of the Month"

Apple Crisp

5 c. apples, sliced
1 c. brown sugar
¾ c. Bisquick flour
¾ c. oatmeal
1 tsp. cinnamon
¼ c. butter

Butter a 9x9-inch pan. Arrange apples. Mix sugar, flour, oatmeal and cinnamon. Cut in butter. Sprinkle over apples. Bake at 350° for 45 to 50 minutes.

After tasting this, you may discard all of your other apple crisp recipes!

Apple Cake

9 T. butter
3 Golden Delicious apples, peeled, cored & sliced
1 ½ c. flour
1 ½ tsp. baking powder
1 tsp. cinnamon
½ tsp. salt
1 c. sugar
Grated zest of 1 lemon
2 lg. eggs
1/4 c. milk
Powdered sugar, for dusting
Cinnamon, for dusting

Melt 1 tablespoon butter in a skillet over medium heat. Add apples and cook until softened, about 10 minutes. Preheat oven to 375°. Butter well, then flour a 6-cup bundt pan. Combine flour, baking powder, cinnamon and salt; set aside. In a large bowl, beat remaining 8 tablespoons butter with the sugar and lemon zest until light and fluffy. Beat in eggs, one at a time, until well mixed. Using a wooden spoon, beat in flour mixture in 3 batches, alternating with milk in 2 batches. Stir in apples. Scrape batter into pan and bake in the center of the oven until a toothpick stuck in the center of the cake comes out clean, 50 to 60 minutes. Turn out on a wire rack and cool. Just before serving dust with powdered sugar and cinnamon. Serve with whipped cream, if desired.
